Participants' Biographies



Professor Tim Benton

Tim is Distinguished Fellow in the Environment and Society Programme at Chatham House, having served as Research Director and head of the Centre since 2019. He first joined Chatham House in 2016 as a visiting fellow, at which time he was also dean of strategic research initiatives at the University of Leeds. From 2011-2016 he was the 'champion' of the UK's Global Food Security programme which was a multi-agency partnership of the UK's public bodies (government departments, devolved governments and research councils) with an interest in the challenges around food.

As a leading advocate on food systems transformation, he has worked with UK governments, the EU, G20 and a range of other governments around the world, as well as leading businesses and civil society organisations. He has been a global agenda steward of the World Economic Forum, and was an author of the IPCC's Special Report on Food, Land and Climate (2019), and the UK's Climate Change Risk Assessment (2017, 2022).

He has published more than 200 academic papers, many tackling how systems respond to environmental change. His work on sustainability leadership has been recognised with an honorary fellowship of the UK's Society for the Environment, and a doctorate honoris causa from the Université Catholique de Louvain, Belgium. He also remains a (part time) Research Professor at the University of Leeds.



Ms Sarah Bradbury

Sarah has more than 25 years' experience in retail, most recently as Group Quality Director at Tesco. She is responsible across the group for delivering high-quality safe products, sustainability, agriculture and regulatory compliance, as well as working collaboratively to influence and drive change across the entire supply chain. Prior to this, Sarah held senior commercial and marketing positions at both Tesco and Aldi.

Sarah has previously co-chaired IGD's Technical Leadership Forum, one of the organisation's critical working groups that is helping to drive change and mobilise the food and consumer goods industry as a force for good.



Miss Barbara Bray

Barbara is a Registered Nutritionist and food safety consultant.

Her work over the last 30 years focussed on delivering food safety in food supply chains and nutrition strategy for businesses, alongside leadership and educational roles in her public engagement activities.

She is currently researching diets to protect health of older adults at Queen's University Belfast under the BBSRC funded Doctoral Research Programme to train PhD researchers in food systems.

In 2017, Barbara was awarded a Nuffield Farming Scholarship to study international food and farming systems.

In 2019, Barbara was awarded an MBE in the Queen's Birthday Honours list for her 'Services to Food Nutrition'.



Professor Lisa Collins

Lisa is Professor of Animal Science and her expertise spans interdisciplinary research in food security, animal health and welfare and agricultural sustainability, with a particular focus on the development and application of smarter agricultural systems for healthy animals, people, and environment, through approaches including technology development, systems modelling and data analytics. Amongst a broad portfolio of research projects, Lisa led PIGSustain, a £2.06m Global Food Security programme grant and is currently leading a world-first field trial of Regenerative Agriculture practices as part of the FixOurFood project.

Lisa serves on national and international advisory, funding and academic society councils and strategy groups, including Defra Science Advisory Council, is chair of BBSRC's Strategic Advisory Panel for Biosciences for the Integrated Understanding of Health, a board member for the Sustainable Aquaculture Innovation Centre, ScotGov's Rural and Environmental Science and Analytical Services Division, and is on the Editorial Board for *The Conversation*. In 2014, she received the British Science Association Charles Darwin Award for excellence in science communication, and in 2010, the UFAW Young Animal Welfare Scientist of the Year award. She is a Fellow of the Learned Society of Wales, the Royal Society of Biology and Royal Statistical Society and was the British Science Association Section President for Agriculture and Food for 2020-2022.

Lisa recently moved to the University of Surrey where she has taken up the role of Pro Vice Chancellor for Research and Innovation. Prior to this, Lisa was N8 Agrifood Chair in Agricultural Systems, Director of the National Pig Centre and Deputy Director of the Global Food and Environment Institute at the University of Leeds.



Mr ffinlo Costain

ffinlo is the Editor-in-Chief of 8point9.com and has worked in farming, land and food business policy for over 20 years. As Chief Executive of Farmwel (2016-2022) he gave evidence to UK parliamentary committees and advised ministers and the Committee on Climate Change on the role of agricultural climate gases. ffinlo founded the Food & Global Security Network in 2020 and published Soil Health: A security threat profile, prior to COP26. ffinlo has presented at the European Parliament and advised ministers and senior leadership teams in many European countries. His TEDx Talk, 'We can't solve the climate crisis without cows', has proved highly popular with regenerative farmers and innovators.



Mr Robert Craig

Robert is a passionate, progressive dairy farmer, holding several high-profile dairy industry positions.

Over the past 40 years, Robert has grown the small 40-cow family dairy farming business to its current scale farming on three sites totalling around 800 hectares and milking 1500 cows in Cumbria and Northumberland. Operating a predominantly spring calving, pasturebased system of milk production all the milk is supplied to First Milk on a constituent based contract, aligned to Nestle on two of the three farms. Away from the farms, Robert has served a full term of 6 years as a director and vice chairman of dairy cooperative First Milk. Robert also represented the coop at the trade association Dairy UK where he chaired the Farmer Forum. Robert is also a trustee of Stoneleigh based The Royal Association of British Dairy Farmers and is currently acting as the charity's executive-chairman. Robert was awarded a Nuffield Scholarship in 2012 to study food chain sustainability and is still involved in various associated activities since his scholarship, most notably The Sustainable Food Trust. Robert is also a non-executive director at PFK, an Estate, Property and Land Agency operating locally in Cumbria. Robert is married to Jackie and they have four children all now grown up and finding their way in the world. Along with Jackie, Robert enjoys fell walking, cycling, Kayaking, running and Formula One.



Mr Tom Curtis

Tom is one of the three founding Directors of 3Keel, which is consistently listed by the Financial Times as one of the UK's top sustainability consultancies. Tom is also the originator of the Landscape Enterprise Networks (LENs) approach. Operating in multiple jurisdictions across Europe, LENs enables businesses to share the cost of securing the future of landscapes they depend on.

Tom's background is in forestry and mixed farming, and outside of 3keel he is Chair of Trustees at the Soil Association Land Trust, and on the organising committee for Food and Farming Consultations at St George's House.



Professor Bob Doherty

Bob is the founding Dean of the School for Business and Society at the University of York and leads a funded 5-year research programme called 'FixOurFood', from the UK Transforming Food Systems Strategic Priorities Fund. Previously, Bob led the interdisciplinary research programme on food resilience titled '*IKnowFood*' (Global Food Security fund) funded in 2017. Bob was seconded in April 2019 for three years into the UK Government Department, DEFRA (Department for Environment, Food and Rural Affairs) as a policy fellow to work on Food Systems policy development. Bob specializes in research on pro-social market mechanisms in the food system, including hybrid organizations and certification bodies.

He is a former trustee (6-years) on the board of the Fairtrade Foundation and a member of the Grow Yorkshire Board. Bob sits on the UKRI Sustainable Agriculture and Food Strategy Advisory Panel in the BBSRC Research Council. He is Founding Editor Emeritus of the Social Enterprise Journal (published by Emerald publishers) after 10-years as Editor in Chief. Bob also prior to moving into academia spent 5-years as the Head of Sales and Marketing at the Fairtrade social enterprise pioneer Divine Chocolate Ltd and 8 years in the Global Animal Health Industry.



Dr Pete Falloon (FRMetS, FRSA)

Pete is the Met Office's Science Lead – Food Security, and leads the Met Office's Climate Service for Defra on Food, Farming and Natural Environment. Pete has over 25 years of experience in the impacts of climate and land use change on food systems and the environment. Pete has been at the Met Office Hadley Centre since 2004 and led the Climate Impacts Modelling team from 2009-2019. He is a Fellow of the Royal Society of Arts, and of the Royal Meteorological Society, a contributing author to the UK's Climate Change Risk Assessment (CCRA) and a member of the Global Food Security Programme's Programme Coordination Group board. Pete is also Associate Professor in Climate Resilient Food Systems at the University of Bristol, Sustainability Director for Food Drink Devon CIC and an Honorary Associate at the Walker Institute.

Mike is responsibility for crop and livestock genetics and breeding, animal health & welfare and research at AHDB, and the development of a holistic approach to farming system development, food production and one health.

She has successfully delivered previous projects with the National Fire Chiefs Council, the National Police Chiefs Council, and other organisations. She was the embedded scientist for the Covid 19 National Foresight Group (for which she was awarded an MBE). Susan is Professor of Diet and Population Health in the Nuffield Department of Primary Care Health Sciences at the University of Oxford and a Senior Research Fellow at Jesus College. Her research centres on how what we eat affects the health of people and the planet and how we might support a change towards healthier and more sustainable diets. To this end, her research team develop and test interventions that aim to change the behaviour of individuals, food businesses and policymakers – with a focus on avoiding overconsumption and limiting intake of meat.

Susan has worked extensively with governments in England to encourage dietary change. She was the science advisor for the Foresight obesity report and subsequently seconded (0.2FTE) to the Department of Health as a science advisor on obesity and food policy (2007-2015). She is currently Chair of the UK Food Standards Agency.

Since that point Thriplow Farms became one of the first farms in the country to successfully and fully adopt regenerative farming practices such as no-till, cover cropping, and high density planned grazing. The farm is highly involved in environmental schemes, including both Mid and Higher tier Countryside Stewardship, and the Sustainable Farming Incentive. David has also spent four years on the AHDB Cereals and Oilseeds Sector Council.



Mr Hugh Ward

Commissioned into the Royal Engineers in 1986, Hugh has served in mechanised, light, air support and commando units on operations from warfighting, peace keeping to disaster relief. In 1992, Hugh was part of the successful British North Geomagnetic Pole Expedition.
